

Renewal Overview



- Waiver renewals are approved by Centers for Medicare and Medicaid Services (CMS) every 5 years.
- The next Comprehensive & Community Support Waiver renewals are due July 1, 2021.



Services Advisory Team



- Met from 2018 to 2019 to look at ways to enhance the service delivery system capacity and increase individual's independence. Team included:
 - Self-advocates
 - **P** Families
 - Providers
 - Targeted Case Management (TCM) entities
 - ♠ State staff

New Editions TA



- OMS granted New Editions to provide Technical Assistance (TA) during the waiver renewal process.
- TA provided guidance on best practices and clarifying language for waiver services.

New Waiver Services & Definitions



Benefits Planning

• Designed to inform an individual about competitive integrated employment and assist them to assess if it will result in increased economic self-sufficiency and/or net financial benefit through the use of various work Social Security and Medicaid work incentives

Home Delivered Meals (CSW only)

 Designed to offer the preparation, packaging, and delivery of meals to individuals who are unable to prepare or obtain nourishing meals.

Individual Directed Goods & Services

• Offers flexibility and increased independence that may cover a service, support, or goods

Intensive Therapeutic Residential Habilitation (Comp Waiver only)

• Designed to provide clinical services to high-risk behavioral individuals when all other methods have been exhausted and not successful. The goal is to support the individual to be successful in their community.

1915(b)4 Selective Contracting Waiver



The 1915(b)4 will be submitted with the Comprehensive Waiver Renewal

What is it for?

To selectively contract with providers of the Intensive Therapeutic Residential Habilitation service, which limits freedom of choice of providers

Why is it needed?

To ensure providers have the required skill set needed and to optimize quality outcomes for all individuals receiving this service.

Definition Clarifications



Personal Assistance

 Provides ongoing support of activities of daily living (ADL) and/or instrumental ADL to the individual

Individualized Skill Development

• Assists individuals to learn specific skills necessary for independent living.

Community Networking (previously Community Integration)

 Assists individuals to learn how to choose activities in the community that build social relationships specifically for the individual.

Definition Clarifications – cont'd



- Support Broker
 - Assist with navigating Goods and Services
- Community Transition
 - Added Clothing and internet service set-up to the allowable expense list
 - Added TV service or media players to the essential furnishings exclusion list.
- Individual Supported Living (ISL)
 - Aligned the sets of principles with 9 CSR 45-5.010
- Professional Assessment and Monitoring
 - A Service is not intended for continuous care

Definition Changes



Assistive Technology

- Must include at least one of the following components: Consultation, Equipment, Service Delivery, and AT Support
- Added Warranty at purchase
- Implementation of service may include internet services

Crisis Intervention

- Develop and writing a formal intervention plan
- Provider
 qualifications are
 updated to

Out of Home Respite

Added new provider type:
 Shared Living Host Home/Relief Home and Stand-Alone Respite Facility

Environmental Accessibility & Adapotations

 Service can be used toward the purchase of existing adaptations in a pre-owned vehicle.

Definition Changes – Cont'd



Employment Outcomes Added

Career Planning

- A career plan/discovery report that outlines and summarizes future employment support needs, skills, interests and preferences.
- A plan for job development which outlines strategies and actions needed to engage potential employers

Job Development

- A monthly summary of job search activities and identification of ongoing supports needed to secure a job
- A job placement plan to include job title, wage, projected number of hours to be worked weekly and implementation strategies for paid/natural supports

Supported Employment

A monthly summary of the professional observation and ongoing assessment of paid/unpaid supports to maintain employment.

Prevocational

- ! Identification of the skill(s) being developed.
- Actions steps needed to develop the skill(s)
- Progress measures

Limitation Changes/Clarifications




- Individuals who receive Group Home, ISL, and Shared Living services shall not receive:
 - Personal Assistant,
 - ! Individualized Skill Development, or
 - Community Networking Services



Hospital language



For individuals hospitalized, Personal Assistant, Group Home, Individual Supported Living, Applied Behavior Analysis, Shared Living support services may be provided to assist with supports, supervision, communication, and any other supports that the hospital is unable to provide.



Service Removal



- Person Centered Strategies Consultation and Counseling
 - The impact of COVID-19 has had unexpected widespread ramifications across our state. A significant General Revenue shortfall has required each state department to review programs and services. The Division identified two services where the needs could be accommodated through other means. The Division is proposing to remove Person Centered Strategies Consultation and the Counseling waiver services effective March 1, 2021.

Seclusion



Seclusion is no longer permitted.

In the event that seclusion or time out is reported or discovered, the special review process will be instituted as outlined in Division Directive 4.200.

Performance Measures



- Meeting the federal HCBS waiver assurances is a requirement. This allows a state to continue to operate the waiver and receive federal funding to meet identified needs of individuals.
- The Division develops performance measures to show that the federal HCBS waiver assurances are being met.
- The performance measures are reviewed and may be revised when quality monitoring processes are enhanced or with additional data availability.

Performance Measures — cont'd



- Performance measure revisions are a component of continuous quality improvement.
- With the current waiver renewal process revisions have been made to performance measures under Qualified Provider and Health & Welfare
