What about vaccination? And again, vaccination status is something that helps protect you, but what we look at are reproductive rates and positivity rates in the community. And so we are going to have to continue to educate folks around that.

March 23rd, we start to see some shelter in place orders.

April 10th, we have a 1st death within our own community within the Department of mental health and so it's important for us to remember that dates can look different for everyone. We, all have different anniversary dates with this.

they might talk about the law that we have endured and so we know when each triggering events happen that that time during the anniversary can increase the stress level within our Natalie,

the individuals but our communities as well.

We also know there can be seasonal changes that remind survivors of the disaster. There are personal events like birthdays that might correspond with the disaster anniversary or even just remembering what you were doing this time last year.

Personal losses also might be associated with the disaster thinking about what we have lost in the last year.

Events we have lost people, we have lost.

Jobs we have lost all of these could be an event, and these triggered events can change. They may increase their frequency around the disaster anniversary. They can occur unexpectedly. They're unique to each 1 of us.

How I respond is going to be very different than how you respond.

And they may not be something that we easily recognize within ourselves.

So, during the anniversary, we know we might see feelings and hear feelings, fear, sadness and anxiety. People might start anticipating how this is going to look.

And days, weeks and months before this even happened, there could be a lot of fear and concerned about how this this event is going to make us feel and how we're going to respond to it.

We also know that there are some typical individual reactions that we might see around the disaster anniversary.

Individuals can experience those reoccurring thoughts or feelings or dreams, but memories about the event, they might see repeated images and scenes associated with that event or we live that event in their mind.

There might be grief and sadness related to lots of income or job, or loved 1.

There could be fear and anxiety that resources around this time, at least jumping in and struggle responses and maybe even more about safety here.

We also can see frustration, anger, start happening more people are being reminded about those losses and that's not just the losses of the loved ones that can be awesome time taken out of our lives.

So, we can see frustration and anger increasing. We also might see guilt about survival here.

Pondering those we've lost, we also might give reflection looking back on where we've come this past year. How how.

We've overcome those challenges the courage, the endurance had taken the resource, the resource forcefulness that we have shown in the recovery process, and we also could see restlessness here.
