The <u>Connexion case management</u> project is currently in the design and development phase with configuration of multiple applications, including but not limited to service planning, provider application, provider enrollment, provider certification, and quality monitoring. The initial phase of interface design and development is beginning in April 2021, with a total of 10 interfaces being configured through the project.

As of April 2021, the project is 36% complete. The project schedule is currently being finalized to include a pilot and go-live date in 2022.

### **CDC Updates Vaccine Resources for Disability Populations**

The Center for Disease Control and Prevention (CDC) has updated the page on its web site titled "<u>Vaccine Considerations for People with Disabilities</u>." This webpage provides information for people with disabilities or conditions that may increase their risk of getting and spreading COVID-19, and for their care providers. The CDC also updated the resource page titled "<u>Guidance for Vaccinating Older Adults and People</u> with Disabilities for Vaccination Sites," which contains guidance for vaccination clinics and providers to ensure that they are prepared to accommodate the needs of these populations when they receive vaccination services.
