The Division is working on closing out requirements and moving into configuration and testing work with FEI Systems. Detailed requirement sessions have been held on the Individualized Support Plan and Monitoring, Quality Assurance, Consumer Referral, Service Definitions, Service Packet, and Billing and Claims. Additional sessions will continue to refine requirements for the new case management system through 2021.

In addition, the Division is working with FEI on an updated detailed project schedule with additional tasks and revised start and end dates. The Division anticipates unveiling those in November 2021. The proposed re-baselined project schedule has a go-live date of October 2022 for a pilot, November 2022 for full go-live, and project end date of September 2023 (to be inclusive of stabilization and CMS certification of the system post go-live). This project is now expected to last a total of 38 months from initiation to close-out.

#### Administration for Community Living / RAISE Family Caregiving Advisory Council

The Administration for Community Living (ACL) was created around the fundamental principle that older adults and people of all ages with disabilities should be able to live where they choose, with the people they choose, and with the ability to participate fully in their communities.

The ACL is leading the implementation of the Recognize, Assist, Include, Support, and Engage (RAISE) Act and facilitates the work of the RAISE Family Caregiving Advisory Council.

<u>RAISE</u> recently delivered its initial report to Congress. This report provides an overview of many of the issues faced by family caregivers nationwide and provides recommendations for addressing them.
