A Division priority is to provide timely updates to all stakeholders on the ConneXion case management project. ConneXion has a dedicated webpage that has been recently updated.

Highlights include:

- All health indicators in green status;
- Currently in Design/Build and Configuration phase;
- Project currently 63% complete;
- Schedule has been re-baselined/updated and includes additional contract amendments;
- Revised Go-Live date May 2023; project end date May 2024.
- Includes a 60-day pilot period and required stabilization and certification period for Center for Medicare Services (CMS);
- Project is expected to last 42 months from initiation to close-out.
