 - Risk Prevention support gets ahead of problem situations by teaching staff and individuals the skills they want and need to avoid ending up in crisis situations, or with involuntary moves, in the first place. On December 2, 2021, Tier 2 leadership presented upcoming changes, including a 3 year timeline, that will help the Division take a more systematic and preventative approach toward transition planning.


